O&P NEWS**PECOS Update - July 6, 2010 Implementation Date Confirmed**

AOPA has confirmed that the implementation date for PECOS enforcement has been changed to July 6, 2010. **AOPA** staff spoke with James Bossenmeyer, the CMS official responsible for PECOS implementation. Mr. Bossenmeyer confirmed his previous statement that provisions of the Patient Protection and Affordable Care Act (PPACA) require PECOS requirements to be effective July 6, 2010.

As previously reported claims received on or after July 6, 2010 that are the result of a referral from a physician without a current PECOS enrollment file are eligible to be rejected. While CMS has admitted that system edits may not be fully functional by this date and therefore claims resulting from ineligible referrals may be paid, it has reiterated that once the system edits are in place, the DME MACs may reprocess these claims, resulting in overpayment requests.

CMS has instructed its contractors, including the DME MACs, to send a letter to physicians in their systems that do not have a current PECOS record. The purpose of the letter, which is supposed to be sent by June 28, will be to provide instructions to physicians regarding how to enroll in PECOS as well as reminding them of their obligation to do so. CMS has published Medlearn Matters Article MM6842 which notifies the provider community that the letter will be sent.

LSO's and TLSO's: Coding Verification Requirement

As reported in a previous AIA, the LSO/TLSO policy has been revised, effective July 1, 2010. The new policy requires LSO's and TLSO's described by codes L0450-L0492 and L0625-L0640 to be reviewed by the Pricing Data Analysis Coding Contractor (PDAC) and listed on the DMEPOS Product Classification List on its website. The policy divides custom LSOs and TLSOs into two categories, and only requires one category to be listed and reviewed by the PDAC.

If custom LSOs and TLSOs described by codes L0452, L0480-L0486, L0629, L0632, L0634, L0636, L0638 and L0640 are fabricated by you, in-house from raw materials and is delivered directly to the patient, you don't have to have the device reviewed by the PDAC. However, upon request, you must be able to provide a list of the materials used and a description of your fabrication process.

If the custom LSO or TLSO is fabricated by an outside entity (i.e. a manufacturer or central fabrication site), then the device must be reviewed by the PDAC and listed on its website. If a device has not been verified and listed by the PDAC, it must be billed as an A9270, a non-covered service. AOPA has contacted the PDAC to obtain further clarification of its expectations regarding this category of device.

All prefabricated LSO's and TLSO's described by codes L0450, L0454-L0472, L0488-L0492, L0625-L0628, L0630, L0631, L0633, L0635, L0637 must be reviewed and listed on the PDAC website. If a device has not been verified and listed by the PDAC, it must be billed as an A9270, a non-covered service.

Update: Red Flag Rules Delayed

On May 28, 2010, just shy of the June 1st compliance deadline, the Federal Trade Commission announced that it would again be postponing enforcement of the Red Flags Identity Theft Prevention Rule through December 31, 2010. This delay comes at the request of Congress, which has been considering legislation (which has been referred to the Senate Committee on Banking, Housing, and Urban Affairs) that would affect the scope of entities covered by the Rule. The FTC "urges Congress to act quickly to pass legislation that will resolve any questions as to which entities are covered by the Rule and obviate the need for further enforcement delays." If Congress passes legislation limiting the scope of the Red Flags Rule with an effective date earlier than December 31, 2010, the Commission will begin enforcement as of that effective date.

Anna Avakian, CPO from Washington D.C. has volunteered to serve the next three-month term as lead prosthetist at the [Hanger](#) prosthetics clinic in Deschapelles, Haiti. She is succeeding **John "Jay" Tew**, a Hanger practitioner from Baton Rouge, Louisiana, who provided essential prosthetic care to Haitian amputees injured in the January 12 earthquake. Fully functional since February 22, 2010, the Hanger Clinic in Deschapelles has already achieved success and under the leadership of Tew; to date, **more than 300 Haitian amputees** have been fitted with prosthetic limbs created at the clinic.
