<p>An Interim Report from the AOPA Board Meeting Relating to the Proposed Regs under BIPA 427; and In Depth Summary of the Proposed Regulations</p>
--

As was stated in our notice last week, AOPA greatly applauds CMS for finally releasing the Proposed Regulation under BIPA 427. The proposal is far from perfect. That, coupled with: (a) the start of the new Trump Administration and the prospect that the Administration could easily view the Proposed regulations unfavorably as an effort to regulate business; and (b) the fact that all signs indicate there is likelihood of several business interests in potential opposition to the rule make it critically important that AOPA, AOPA members and everyone in the prosthetics and orthotics community provide thoughtful and comprehensive comments by the March 13 deadline.

The AOPA Board of Directors met on Monday, January 16 to discuss key aspects of AOPA's position. The most dominant takeaways from those deliberations were that:

- (1) AOPA will establish a 2-3 week "listening period" when we will invite and encourage AOPA members to review the ten or so categories of potential concerns which likely will need to be addressed in AOPA's comments, AOPA will be surveying members,

that is, inviting input from members around a series of questions we will frame around aspects of the proposed regulation; and

- (2) AOPA has created a committee of Board members composed of 3 patient care professionals and 1 orthotic manufacturer—all four AOPA Board members-- to guide interim decision-making on this issue.

We have asked AOPA's outside legal counsel, Alston & Bird, to prepare a comprehensive summary of the BIPA proposed rule, which may be [viewed by clicking here](#). We also urge you to provide your feedback using the AOPA listening period survey/input" tool. [Click here to take the survey](#).

AOPA will be listening, securing your input before formulating our comments between now and the end of January. At that point, AOPA will also prepare a mechanism to facilitate members submitting their own comments to CMS on the proposed regulation.

In closing, we note with interest two concepts highlighted in a recent article by BNA about the proposed BIPA 427 reg.

A CMS spokesman told Bloomberg BNA, the proposal began appearing on the CMS regulatory agenda around the time of a 2013 letter to the Department of Health and Human Services from 35 House members suggesting that implementing the law could reduce fraud.

A beneficiary advocate, however, expressed concern that implementation of strict requirements on practitioners and suppliers could harm beneficiary access to needed items. "For example, qualified suppliers who submit claims for equipment that were not furnished by an entity that meets these requirements risks revocation of their Medicare enrollment and eligibility to submit claims for any DMEPOS items or services," Ashkon Roozbehani, an attorney for the Center for Medicare Advocacy, told Bloomberg BNA. "A reduction in the number of qualified suppliers available to a beneficiary in their locality may result in loss of access to otherwise unattainable medically necessary items and services."

A very important tactical issue in light all of the above, and which is included in the "AOPA Listening Survey" is that it appears there may be as many as six groups that potentially might oppose the Proposed BIPA regulation. So, among other topics, AOPA will be seeking your thoughts including crystallizing the tactical choice between the very difficult odds in the new Administration of pulling through the proposed regulation applicable to all those persons essentially as written vs. an improved prospect if we are open to some give and take to solidify support (and blunt the poignant criticism that this is an anti-business regulation) by at least some of the potential opponents—do we take a cue perhaps learning from the long history of negotiated rulemaking conflict, etc., or do remain absolutely resolute on the terms exactly as written, even if doing so greatly diminishes the prospect of getting any BIPA 427 qualified provider rule through the process to have the force of law? As noted above, AOPA has created a committee of Board members composed of 3 patient care professionals and 1 orthotic manufacturer—all four AOPA Board members-- to guide

interim decision-making on this issue and all content aspects of its position after reviewing AOPA member input and feedback.

Jurisdiction D DME MAC Releases Quarterly Audit Results

Noridian, the DME MAC for Jurisdiction D, recently released the results of their ongoing audits of Knee Orthoses and Spinal Orthoses. Noridian reviewed 1,529 claims between July 2016 and October 2016 focusing on L1832, L1843, L0648 and L0650. Here were the results:

- L1832: 153 claims reviewed and 152 claims were denied
- L1848: 115 claims reviewed and 114 claims were denied
- L0648: 402 claims reviewed and 315 claims were denied
- L0650: 859 claims were reviewed and 750 claims were denied

Based on these results Noridian will continue its widespread prepayment reviews for L1832, L1843, L0648 and L0650.

CMS Announces Proposed Rule on O&P Qualified Providers

Last week, CMS released a proposed rule that would enact the long awaited provisions of Section 1834(h) of the Social Security Act which "requires that no Medicare payment shall be made for an item of custom-fabricated orthotics or for an item of prosthetics unless furnished by a qualified practitioner and fabricated by a qualified practitioner or a qualified supplier at a facility that meets criteria the Secretary determines appropriate. The statute also establishes requirements for both qualified suppliers and qualified practitioners. The proposed rule would implement these provisions." [Read the full press release from CMS.](#)

Based on the press release, in the most general and preliminary terms, these provisions appear to be in line with what AOPA has supported with the Medicare O&P Improvements Act in defining qualified providers as those accredited with ABC or BOC and that only qualified providers can submit claims for prosthetics or custom-fabricated orthotics. That said, clearly, there are areas of the proposed regulations which will require revisions, edits and improvements, via comments to be prepared and submitted by AOPA and others in the O&P profession. Further analysis of the rule is underway.

This proposal straddles two Administrations - published as a proposal at the end of the Obama Administration, to be acted upon by the new Trump Administration. It will take some time before we even know the new Administration's regulatory intentions as to O&P, and what priority they may or may not have to move this forward.

CMS will accept comments on the proposed rule over a 60 day period from the time the proposed rule appears in the Federal Registrar- with a deadline of March 13, 2017 and will

respond to comments in a final rule. AOPA is currently analyzing the rule and will provide a more detailed summary once it becomes available. [Read the proposed rule.](#)

Revised Medicare Application for DMEPOS Suppliers

Medicare has updated their standard enrollment application, the CMS-855S form. The new form should be used for any new enrollments or changes in information for existing suppliers as of January 1, 2017. A copy of the new enrollment form may be found on the CMS website or the National Supplier Clearinghouse website.

There are no substantial changes to the form, but the new form will allow for better data collection on the types of services and items being provided by DMEPOS suppliers. The revised form also includes information and instructions on the application fee and fingerprinting requirements.

If you are uncertain if you are using the old version or the new version of the 855S form just examine the lower left-hand corner of any page on the form and if it reads “CMS-855S (05/16) “ then you are using the revised form.

DME MACs Announce Format Change for LCDs

The four Durable Medical Equipment Medicare Administrative Contractors (DME MACs) have recently announced that there will be a change to the existing format for Local Coverage Determinations (LCDs). Specifically, the general documentation requirements that apply to all Medicare covered services will be removed from individual LCDs and will be published as a single Policy Article that will apply to all Medicare covered services. The DME MACs have stated in the past that revising and reissuing every LCD to reflect minor changes in general documentation language seemed redundant and overly time consuming.

The DME MACs will be revising the LCDs once the General Documentation Policy Article is written and published.

While this format change does not create any new policies regarding Medicare coverage of O&P services, O&P providers will still be required to meet all of the general documentation requirements even though they will no longer be published as part of every LCD. AOPA will work with the DME MAC Medical Directors to ensure that the General Documentation Policy Article is consistent with what is currently published in individual LCDs and will work to ensure that providers are educated properly regarding general requirements for Medicare coverage.

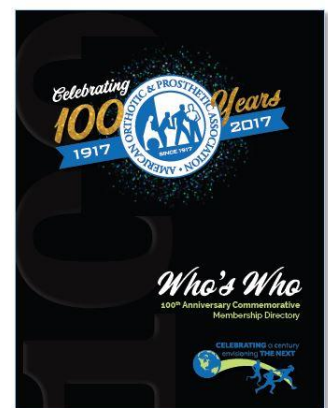
