Submit Comments on CMS' Proposed Rule on O&P Qualified Providers

As you know, CMS released a proposed rule that would enact the long awaited provisions of Section 1834(h) of the Social Security Act, which establishes requirements for qualified suppliers and qualified practitioners, and restricts payments to providers who don't meet those criteria. It is critically important that AOPA, AOPA members and everyone in the O&P community provide thoughtful and comprehensive comments by the March 13 deadline. March 2017 Start Date

Performant Recovery, the Region 5 recovery audit contractor (RAC), has announced in a recent webinar that they plan to begin auditing/reviewing claims in March 2017. The Region 5 RAC is the national contractor responsible for auditing/reviewing all claims for DMEPOS, Home Health, and Hospice services; Performant Recovery was awarded this contract in October 2016. At this time Performant Recovery, the previous RAC for Jurisdiction A, has not identified any O&P issues as potential target areas for future audits/reviews.
