An individual may contribute a maximum amount of \$2,700 per election (the primary and general are separate elections) to a federal candidate. Federal multi-candidate political action committees (PACs) may contribute up to \$5,000 per election. Contributions received after the date of the primary election will automatically be designated towards the general election. All contributions must be from the contributor's personal funds. Corporations and individuals are strictly prohibited from reimbursing another person for making a contribution to Tammy for Illinois.
