### Subject: Great Policy Forum Charted New Pathway to Legislative Solutions for O&P PLUS a Summary of AOPA's Actions on Your Behalf for These Last Three Months.

This year's April 26-27 Policy Forum was a whole new ballgame with a legislation writing session led by former Senator Bob Kerrey who helped bring O&P's concerns about the flawed LCD Policy Article on Lower Limb Prostheses to the highest levels in the White House, Congress and CMS. The more than 140 AOPA members attending the Policy Forum broke into small groups and distilled the major issues challenging O&P providers and patients into a simple one page "ask" legislative measure that is now being used in AOPA's lobbying efforts with the House of Representatives and the U. S. Senate. While many of the provisions captured in the simplified Prosthetic and Orthotic Care Modernization Act are present in other currently pending legislative measures (S. 829 and H.R. 1530), this simplified version offers one more vehicle for O&P to secure legislative action.

Setting the stage for the more than 350 legislative appointments on April 27<sup>th</sup> was the April 21<sup>st</sup> pre-Policy Forum AOPA telenews press event with two amputees, president-elect Michael Oros and AOPA executive director Tom Fise, all of whom drilled home the message of how the flawed LCD proposal seriously impairs timely and appropriate prosthetic care. The proposal was criticized for reverting the standard of care to a 1970's level. They described how private insurance companies were using the flawed proposal to deny otherwise legitimate claims. Media participation spread the message widely throughout the country on TV, radio, newspapers and magazines.

While there was action a plenty during the Policy Forum, there was a huge follow-on effort that included the House Oversight and Government Reform Committee's letter to HHS Secretary Burwell criticizing the LCD efforts of CMS and its contractors and launching an oversight inquiry requesting extensive lists of CMS and DME MAC documents, including public comments, on how the draft LCD proposal was promulgated. Hearings or other oversight committee actions could follow.

Senator Kerrey personally met with key Senators and staff of the Senate Finance Committee and urged adopting S. 829, with some of the clarifying language from the O&P Care Modernization Act.

AOPA past president, Tom Watson, CP, personally shared the harmful LCD events with Senator Majority Leader, Mitch McConnell (R-KY)), who followed up with a letter to CMS Acting Administrator Andy Slavitt on May 5<sup>th</sup> (bit.ly/mcconnellcms) seeking clarification on four issues raised by Mr. Watson:

- What is the current status of the rule? Why hasn't CMS rescinded the draft rule? Is there a plan to retract the proposal in the future?
- Who are the stakeholders involved in the working group? How many prosthetic users and makers are represented in the working group?
- Is the working group considering stakeholder comments submitted on the draft LCD?
- Will the working group provide the industry with updates on the topics being discussed?

With the political turmoil and the shorted time for Congressional business always present in an election year, expectations are still running high that 2016 may see some positive action on the O&P agenda which AOPA and its O&P Alliance partners have been pressing for the past decade.

To further the opportunity for action during what's left of this limited session of Congress, AOPA targeted members in those states whose Senators serve on the Senate Finance Committee urging them to write their Senator asking for their support for S. 829. More than 300 letters from <u>www.AOPAvotes</u> authored by members made this ask. Additional conversations by Tom Watson with Senate Majority Leader McConnell (R-KY) and Senator Kerrey with Minority Leader Reid (D-NV) sought bipartisan support for this non-controversial legislation. Having Senate Finance Committee members responding to a recent letter from Senators Hatch and Wyden by voicing support for "non-controversial bill" treatment for S.829 can build momentum. AOPA Executive Director Tom Fise visited with health advisers to GOP Finance Committee Senators Enzi, Burr, Coats, Roberts, and Portman to try to consolidate more support for the Senate bill. S. 829 received a no cost score from the Congressional Budget Office which helps make it a candidate for inclusion on the list of non-controversial bills that may have a good chance for consideration.

Stay tuned. Now for the other goings on at AOPA these past few months.

## **Legislative Update**

On April 25, Representative Ellmers (R-NC) introduced HR 5045: Preserving Access to Modern Prosthetic Limbs Act of 2016. The bill is "to impose a moratorium on the implementation of a proposed Medicare local coverage determination on lower limb prostheses." The bill would place a moratorium until June 30, 2017 on implementing the July 16, 2015 Draft Local Coverage Determination (LCD): Lower Limb Prostheses (DL33787). The bill also would require that CMS and its contractors remove the policy from their websites, which is necessary because private payers have been adopting provisions included in the LCD. This bipartisan bill was co-sponsored by Rep. Schakowsky (D-IL).

As noted earlier, AOPA and the attendees of the 2016 Policy Forum drafted a new piece of legislation, with the help of former Senator Bob Kerrey titled "The Prosthetic and Orthotic Care Modernization Act of 2016" which focuses on separating O&P from DME, reimbursing only credentialed O&P providers, protecting custom O&P from competitive bidding, and legitimatizing the orthotist/prosthetist notes as a legitimate part of the Medicare beneficiary patient's medical record.

AOPA continues to champion the passage of The Medicare O&P Improvement Act of 2015 (S. 829 and H.R.1530), the most comprehensive legislation aimed at resolving most of the problems facing O&P providers today (e.g. ALJ delays, proper recognition of your notes, the separation of O&P from DME, etc.),

Currently the following Representatives & Senators have signed on in support of The Medicare O&P Improvement Act of 2015: Sen Grassley (R-IA), Sen. Warner (D-VA), Rep. Thompson (R-PA), Rep. Thompson (D-CA), Rep. Stivers (R-OH), Rep. King (R-NY), Rep. Duckworth (D-IL), Rep. Beatty (D-OH), Rep. Heck (R-NV), Rep. Ruppersberger (D-MD), Rep. Israel (D-NY) and Rep. Ellmers (R-NC). # **Coding and Reimbursement Update**

## Medicare Final Rule on Prior Authorization for Certain Prosthetic Items

On December 30, 2015, the Centers for Medicare and Medicaid Services (CMS) released the long anticipated final rule regarding Medicare prior authorization of certain DMEPOS, including most lower limb prostheses.

AOPA's continued concerns regarding the Medicare prior authorization final rule were summarized in the last AOPA staff report but several developments have occurred over the last few months that are relevant for discussion.

Indications remain that implementation of prior authorization is not imminent and will most likely not occur until later in 2016 or early in 2017. CMS has indicated that it intends to implement prior authorization on a smaller scale initially, most likely choosing a small subset of the master list of devices published in the final rule, and implementing prior authorization in select regional markets in order to better evaluate the impact the program may have on beneficiary access to care.

AOPA continues to have concerns with prior authorization of prostheses: (1) that the regulations do not either provide any guarantee of payment or any assurance that a claim on which prior authorization has been obtained will not be subject to post payment medical necessity RAC audits and, (2) that it will critically delay timely access to the provision of prosthetic devices that are crucial to the rehabilitation needs of Medicare beneficiaries. AOPA continues to meet with CMS officials and members of Congress to make sure that prior authorization of any kind will not adversely affect a Medicare beneficiary's access to medically necessary care.

### AOPA Underscores Concerns with Inconsistencies in Veteran's Administration Coding Recommendation

AOPA has recently questioned an apparent unilateral decision by the internal Veteran's Administration (VA) Coding Committee regarding the proper use of codes L5987 and L5986 to describe certain prosthetic feet. The VA Coding Committee issued guidance to its field offices that in order to qualify for L5987, a prosthetic foot must contain a separately identifiable "shock pylon" as part of its construction. Similarly, the VA Coding Committee indicated that in order to qualify for L5986, a prosthesis must contain a "separate and distinct" rotation unit. AOPA has engaged in conversation with the VA regarding this coding guidance and believes that the VA guidance does not take into account the function of prosthetic feet that incorporate a vertical loading pylon through mechanisms other than a traditional vertical shock pylon design as well as features of prosthetic feet that exhibit multi-axial rotation through design features that are incorporated into the foot, rather than through a separate axial rotation unit.

Companies whose feet have been adversely affected by this VA coding policy change have worked with AOPA to better inform interested congressional offices who have requested clarification from the VA regarding this coding guidance that appears to be not entirely consistent with Medicare payment policies for certain prosthetic feet. AOPA will continue its discussions with the Veteran's Administration regarding this issue and report any new developments as they occur. AOPA members can alert lawmakers to the recent VA changes to reimbursement codes that are affecting access to certain prosthetic feet for veterans. There is a letter for veterans, and a separate letter that practitioners can send. These are all available on <u>www.AOPAvotes.org</u>.

## AOPA Comments on the Skilled Nursing Facility Prospective Payment System Proposed Rule for FY 2017

AOPA submitted comments on the CMS proposed rule that will govern payments to Skilled Nursing Facilities (SNFs) during FY 2017. The proposed rule requested input from the public regarding codes that should be considered for exemption from the SNF PPS system. As it has done in the past, AOPA suggested the inclusion of HCPCS codes L5987 and L5969 HCPCS codes to be exempt from SNF PPS. In addition, AOPA suggested including the HCPCS codes that represent partial hands and partial feet for inclusion in the PPS exemption list. AOPA will review the final rule when it is released and report any news of significance to AOPA members.

## Draft Local Coverage Determination and Policy Article for Lower Limb Prostheses

On November 2, 2015, CMS published a notice that based on a preliminary review of the public comments on the draft LCD, the DME MACs would not be finalizing the Lower Limb Prosthesis LCD "at this time." CMS announced it was forming an interagency workgroup in 2016 to "develop a consensus statement that informs Medicare policy by reviewing the available clinical evidence that defines best practices in the care of beneficiaries who require lower limb prostheses."

The inter-agency workgroup has been established and is made up only of employees of federal agencies. To date, the workgroup has met on two occasions and expects to take significant time to formulate a strategy to properly address the LCD issue. The general consensus is that it will take at least a year or more to complete. AOPA continues to make every effort to ensure that any future LCD for lower limb prostheses is advanced through a transparent process, with stakeholder input, so it does not hinder Medicare beneficiary access to medically necessary and appropriate prosthetic services.

## **Revision to Local Coverage Determination and Policy Article for Knee Orthoses**

The DME MACs have recently published a revision to the Knee Orthosis Local Coverage Determination (LCD) and Policy Article (PA) that was effective for dates of service on or after June 2, 2016.

The primary revisions to the LCD and Policy article included the addition of ICD-10 diagnosis codes that allow providers to indicate whether the encounter was considered an initial, subsequent, or sequela encounter; and incorporation of language from the DMEPOS quality standards regarding the definition of custom fabricated orthoses. The revision also incorporates standard documentation language found in other O&P policies.

## **DME MAC Contractor Transition**

The transition of contractor responsibilities for the Jurisdiction A DME MAC and Jurisdiction B DME MAC occurred on July 1, 2016. CGS is now the contractor for both Jurisdiction B and C, and Noridian Healthcare Solutions, LLC is now the contractor for Jurisdictions A and D. The transition appears to have happened relatively smoothly with few issues occurring as a direct result of the transition.

## RAC Audit Update

As a result of the delay of the award of the national DMEPOS, Home Health, and Hospice RAC contract, CMS has authorized the existing four RAC contractors to begin active RAC audit activity. Renewed RAC audits relative to AFOs have been reported in Jurisdictions A and D in significant numbers. AOPA has developed educational material on RAC audits and is presenting a free webinar for members on July 14, 2016 and a paid webinar available to the public on July 21, 2016. One key issue is for members to be fully aware the CMS rules limit CMS contractors to a maximum of 10 additional data requests (ADRs) in any 45 day period.

### **Revised Limitations on the Scope of Review for Redeterminations & Reconsiderations**

The Center for Medicare and Medicaid Services (CMS) has recently issued a revised directive to its contractors handling appeals that are a result of a "complex prepayment reviews, complex post-payment reviews or automated post payment reviews." CMS has informed the Durable Medical Equipment Medicare Administrative Contractors (DME MACs) and the Qualified Independent Contractor (QIC) that during the redetermination and reconsideration levels they may only "limit their review to the reason(s) the claim or line item at issue was initially denied".

This means that the contractors may no longer deny your claim for a different reason upon further review of the claim, they may only review and make a decision based on the initial issue at hand. However, this limit doesn't apply to appeals that are the result of an automated pre-payment review denial. The limit on the scope of review only applies to appeals which are the result of denials due to complex prepayment reviews, complex post-payment reviews or automated post payment reviews.

This is a beneficial shift in policy. Previously, the DME MACs and the QIC could still "develop new issues and evidence at their discretion" and issue unfavorable decisions for any reason besides the one provided with initial determination; even on post-payment reviews. Now, they may only "develop new issues and evidence at their discretion" when a claim is denied on an automated prepayment review basis only.

This revised directive and instructions only applies to redetermination and reconsideration requests received by the DME MAC or QIC on or after April 18, 2016. The revised instructions will not be applied retroactively.

## AOPA Updates its Joint Statement on Physical Characteristics of Orthopedic Shoe Inserts

In 2013, AOPA, in conjunction with the American Podiatric Medical Association (APMA) and the Pedorthic Footcare Association (PFA), developed a joint statement on the interpretation of HCPCS codes L3000, L3010, L3020, and L3030. The joint statement was presented to AOPA leadership at the time and was approved for publication. On May 13, 2016 a follow up meeting of the three organizations was held and a slight revision to the joint statement was proposed with the understanding that the leadership of the three organizations would have the opportunity to review

and approve the revised document. The revised statement has been reviewed and approved by AOPA leadership and is available on the AOPA website at <u>www.AOPAnet.org</u>

### **OTS Orthoses and Competitive Bidding**

Off the Shelf (OTS) orthoses remain eligible for inclusion in future rounds of Medicare competitive bidding but have not been selected as a product category for the most recently announced phase, known as Round 1 2017, scheduled to be implemented for January 2017. AOPA will continue to monitor this issue closely.

### AOPA Participation on DME MAC Advisory Councils

AOPA continues to actively participate on each of the four DME MAC Advisory Councils. These groups meet on a regular basis with representatives of the four DME MACs to discuss provider issues. AOPA has been able to create and maintain open lines of communication with Medicare contractors as a result of participation on the advisory councils.

### **Mastering Medicare Webinars**

# **AOPA Clinical O&P Research Support**

## **AOPA Funds Pilot Grants**

AOPA, in partnership with the Center for O&P Learning & Evidence-Based Practice (COPL), announced a Request for Pilot Grant Proposals in 16 potential areas of orthotic and prosthetic research including an open topic. Twenty-seven applications were received, and the high quality of the proposals led the Board to choose to fund seven of the grants, well above the usual three or four that are usually funded.

## The RAND Research Project

After reviewing proposals from RAND Corporation and two other health economics "think tanks," AOPA in conjunction the Prosthetics 2020 program has entered into an agreement commissioning RAND Corporation to complete a comprehensive, independent, validated study to establish the value proposition for prosthetic services to amputees. In addition to the study and final report, it is expected that this joint effort will likely end up comprised of three components- the study and final report, as well as a free-standing modeling tool based on the RAND simulation and a white paper outlining AOPA's vision.

It was the unanimous view of the AOPA Board and Executive Committee that current circumstances demand the most comprehensive and credible possible look at the prosthetic value proposition and reimbursement picture, and that the RAND proposal seemed uniquely positioned to satisfy those needs.

## AOPA Prosthetics 2020 Technical Advisory Committee

The AOPA Prosthetics 2020 Technical Advisory Committee has been formed to assist with the Rand Corporation study and other research efforts supporting the Prosthetics 2020 project. Representatives to this committee include Dr. Andreas Kannenberg, Dr. Jason Highsmith, Dr. Kenton Kaufman, Kim DeRoy, Stephen Blatchford, Sam Liang, AOPA President Jim Campbell, AOPA President –Elect Michael Oros, and AOPA Executive Director Tom Fise. The committee will meet monthly via teleconference to keep the project advancing forward.

## AOPA Google+ Community

During the 2016 AOPA Policy Forum AOPA launched a pilot phase of a Google+ Community. This community will serve as a forum to discuss issues facing the O&P profession and to develop advocacy strategies to address those issues. The concept itself was developed as part of the Mobility Saves committee with emphasis on the need for a forum where members could engage in conversation about issues with other members. The forum will allow members to benefit from shared information when they encounter similar challenges. The pilot phase of the AOPA Google+ Community currently includes members serving as AOPA State Representatives.

## AOPA Compendium

AOPA is currently developing a new member benefit that will function much like a Wikipedia for reimbursement information. The vision is for this site to serve as a collection of concise, but detailed information with additional links to supporting documentation about the topics most important to our members. Much like Wikipedia, this compendium will have a crowdsourcing component, garnering the vast knowledge and experience of our membership body. A workgroup, led by AOPA President-Elect Michael Oros, CPO, FAAOP and supported by AOPA Executive Director Tom Fise, Ashlie White, AOPA Manager of Projects and others on the AOPA staff will continue to develop this concept with the goal to have a beta version ready to launch by the end of 2016.
