Subject: A long awaited legislative victory kicks off AOPA's 101st year!

AOPA has been advocating for the recognition of prosthetist and orthotist's notes for purposes of medical necessity since the 2011 "Dear Physician Letter", and in February, Congress enacted a provision doing just that. AOPA also spent the first quarter of 2018 challenging CMS' attempts to reimburse less for diabetic shoe inserts based on fabrication methods, and achieved another victory when CMS agreed to continue to reimburse the new codes at the same level paid for A5513. This positive outcome potentially sets a precedent for other codes where new technology may replace older fabrication methods. AOPA organized another successful Policy Forum with nearly 100 attendees, continued planning the 2018 National Assembly, and released RFPs for research grants for Orthotics 2020 in addition to the annual COPL pilot grants.

Government Affairs and Legislative Round Up

O&P Practitioner Notes Now Considered Part of the Patient's Medical Record

Included in the Continuing Resolution that was passed by Congress on February 9th was a key component of the O&P Medicare Improvements Act, which AOPA, its lobbyists, its members, and many important friends in O&P worked diligently on for several years!

The legislative language is as follows:

SEC. 50402. ORTHOTIST'S AND PROSTHETIST'S CLINICAL NOTES AS PART OF THE PATIENT'S MEDICAL RECORD. Section 1834(h) of the Social Security Act (42 U.S.C. 1395m(h)) is amended by adding at the end the following new paragraph:

"(5) DOCUMENTATION CREATED BY ORTHOTISTS AND PROSTHETISTS.-For purposes of determining the reasonableness and medical necessity of orthotics and prosthetics, documentation created by an orthotist or prosthetist shall be considered part of the individual's medical record to support documentation created by eligible professionals described in section 1848(k)(3)(B)."

This simple clause provides confirmation that orthotist/prosthetist notes will be considered by CMS to be officially part of the patient's medical record for purposes of medical necessity, and RAC and pre-payment audits.

While this provision does not address the entire Medicare O&P Improvements bill (S.1991/HR2599), it represents a significant step forward in the recognition of O&P providers as legitimate members of the overall rehabilitation team.

AOPA Secures Advocacy Victory on Fee Schedule for Direct Milled, Custom Fabricated Diabetic Inserts

On January 11, 2018, as part of its quarterly HCPCS update, the Centers for Medicare and Medicaid Services (CMS) issued a new HCPCS code to describe direct milled, custom fabricated diabetic inserts. The new code became effective April 1, 2018 and reads as follows:

K0903--For Diabetics Only, Multiple Density Insert, Made By Direct Carving With CAM Technology From A Rectified CAD Model Created From A Digitized Scan Of The Patient, Total Contact With Patient's Foot, Including Arch, Base Layer Minimum Of 3/16 Inch Material Of Shore A 35 Durometer (Or Higher), Includes Arch Filler And Other Shaping Material, Custom Fabricated, Each

The new code is categorized as a "K" code which is technically a temporary code designed to allow CMS to track utilization prior to deciding whether to issue a permanent HCPCS code, in this case an "A" code. Any codes that are created mid-year must be issued as "K" codes.

The purpose of the K code is to differentiate between custom fabricated diabetic inserts that are molded over a physical model of the patient's foot (A5513) from those that are direct milled based on a digital or virtual model of the patient's foot. While both manufacturing processes result in functionally identical custom fabricated, total contact inserts, CMS has indicated that direct milled inserts, while qualified to meet the DMEPOS Supplier Standards definition of molded to patient model, do not meet the requirements of A5513 and proposed a fee schedule reduction of approximately 14%. AOPA challenged this premise based on several bases, including provisions within CMS' own instructions to contractors that require the direct crosswalk of established Medicare fee amounts when a single code is exploded into two or more similar codes. Ultimately, CMS reached the right decision that as the processes were essentially equivalent, the fee needed to also be identical and announced that the Medicare fee schedule for K0903 would be equivalent to the existing fee schedule for inserts described by A5513.

AOPA had tremendous support on this issue from the American Podiatric Medical Association, the O&P Alliance, and Rep. Brad Wenstrup's office and appreciates their support on this important issue that may have greater effects on future decisions related to Medicare reimbursement for enhancements in technology.

Introduction of H.R. 4772

Rep. Mike Bishop (R-MI) introduced H.R.4772 – a subpart from the earlier H.R. 2599 Medicare O&P Improvement Act, this would amend title XVIII of the Social Security Act to provide for clarification under the Medicare program about minimal self-adjustment for off-the-shelf orthotics.

This bill would clarify that "off-the-shelf (OTS) orthotics" eligible for competitive bidding be limited to those devices that require minimal self-adjustment only by the patient, and not another person in order to fit the patient. The bill is co-sponsored by Mike Thompson (D-CA) and Glenn Thompson (R-PA). AOPA members may send a letter to their congressional representatives through the AOPAvotes website at www.aopavotes.org.

OIG Targets L0648, L0650, and L1833 in its 2018 Work plan

As part of its update to its 2018 work plan, the Department of Health and Human Services Office of Inspector General (OIG) announced that, based on abnormally high utilization and unusually high improper payment rates, two off the shelf (OTS) HCPCS codes that describe lumbar sacral orthoses (L0648 and L0650) and one OTS knee orthosis code (L1833) will be added as an area of focus for investigation by the OIG. All three codes identified by the OIG are part of the split code set created by CMS in 2014 that differentiated OTS orthoses from those that require the expertise of a certified orthotist or an equivalently trained professional.

In its announcement the OIG reported that, since 2014, claims for the three OTS codes have grown by 97% with allowed charges rising to \$349 million in 2016. The OIG plans to explore questionable billing practices for these three codes including the lack of medical necessity documentation from referring providers and instances where no patient/physician encounter occurred within the 12 months prior to provision of the orthosis.

Based on Medicare utilization data from 2014 until 2016 AOPA has determined that less than

10% of the OTS devices described by L0648, L0650, and L1833 were provided by traditional O&P companies. The vast majority of these devices, over 65%, were provided by DME suppliers without certified O&P professionals on staff.

While traditional O&P providers represent a small percentage of the overall utilization of these three codes, it remains wise to make sure that, when providing OTS orthoses described by these codes and any other codes, proper medical necessity documentation is maintained by the ordering physician and all Medicare policy requirements have been met. While L0648, L0650, and L1833 have not previously been identified as approved for RAC review, the outcome of the OIG review may possibly lead to additional audit activity by the RAC and other contractors.

CMS and Veteran's Administration Announce Partnership to Strengthen Prevention of Waste, Fraud, and Abuse Efforts

On January 23, 2018, the Centers for Medicare and Medicaid Services (CMS) and the US Department of Veterans Affairs (VA) announced a new partnership in which they will share data, data analytics and best practices in an effort to improve both agencies' efforts to combat waste, fraud, and abuse in their respective healthcare delivery systems.

The VA and CMS represent the two largest public-private healthcare organizations in the country. According to the press release, the partnership will allow the VA to take advantage of gains in data analytics developed by CMS through its Center for Program Integrity.

While the press release discussed general efforts to improve efforts to eliminate waste, fraud, and abuse and made no specific mention of orthotics and prosthetics, the announcement is a clear indication that the VA will be placing increased scrutiny on all providers in the future. While AOPA supports efforts to eliminate fraud and abuse within the healthcare sector, it must be done in a manner that does not inadvertently lead to unnecessary restriction to access to medically necessary care for veterans and Medicare beneficiaries.

Office of Medicare Hearings and Appeals (OMHA) Announces Low Volume Appeals Settlement Opportunity

In an effort to address the current backlog of cases that are awaiting a hearing before a Medicare Administrative Law Judge, the Medicare Office of Hearings and Appeals (OMHA) announced a voluntary program that would offer providers the opportunity to settle certain pending claims for a reduced fee.

Suppliers that have fewer than 500 appeals pending at Administrative Law Judge level or higher and each appeal has a total billed amount of \$9,000 or less can file an expression of interest for a limited settlement agreement. The agreement will result in a timely one-time partial payment of 62% of the net Medicare approved amount of the appeals in question.

The deadline to file an expression of interest to participate in the low volume appeals settlement program is June 8, 2018.

AOPA Submits Comments on Proposed Rule that Would Change Rules on Coverage of Essential Health Benefits for Association Health Plans

On March 6, 2018, AOPA submitted comments on a proposed rule that would change the definition of the term "employer" as it relates to association health plans and the requirement to cover "essential health benefits" under provisions of the Affordable Care Act (ACA).

The proposed rule states that by expanding the definition of the term "employer" association based health plans will have new opportunities to negotiate terms with insurance companies that will benefit its members. AOPA's primary concern with the proposed rule is that the proposed expansion of association health plans will significantly reduce the requirements for these plans to provide coverage for health benefits, including orthotics and prosthetics, which have been designated as essential health benefits by provisions of the ACA.

DME MACs Revise AFO/KAFO Policy

The DME MACs recently released a series of revisions to the AFO/KAFO Medicare medical policy with an effective date of 01/01/17. The revisions were predominantly clerical (e.g. include language associated with the 21 Century Cures Act and updating the list of off-the-shelf/custom fitted braces) and should not have a direct effect on your coding, billing and medical necessity determinations. In addition the revised policy now states in writing that walking boots (L4360, L4361, L4386 or L4387) are all inclusive and may not be billed with any other add-on codes.

2018 AOPA Policy Forum

The 2018 AOPA Policy Forum held March 7-8 was another success that presented realistic opportunities for O&P stakeholders to meet with Congressional representatives to improve patient care and advance other legislative objectives. With a recent legislative win under our belts, AOPA members and O&P users traveled to DC to visit lawmakers to build on this momentum, presenting their stories of the impact O&P makes on patients' lives, and suggesting common sense solutions to issues obstructing O&P interventions.

Ninety-six O&P professionals and patients donned their advocacy hats during the March 8 visits to Capitol Hill, and met with their Representatives and Senators. Attendees encouraged lawmakers to support the Medicare O&P Improvement Act – the clinical notes provision was one part of the bill, but seven provisions remain that have not been enacted. Attendees also requested support for additional funding for O&P research and education, expressed the importance of Veterans' Choice, and took the opportunity to share other issues facing their patients and their businesses. The impact of the visits is not always immediate, but the cumulative effect of hearing from patients, clinicians, manufacturers, and AOPA and other O&P organizations is how we get lawmakers to share our concerns and recognize our responsibility in the rehabilitative process.

In addition attendees also heard from Congressional members Rep. Peter Roskam (R-IL), Rep. Mike Bishop (R-MI) and Sen. Ben Cardin (D-MD), who shared their insights on healthcare and their advice for advancing O&P's legislative agenda.

Research and Projects

Orthotics 2020

As part of AOPA's Orthotics 2020 initiative, we are committed to making a major leap forward in clinical research that can answer some of the most important and profound issues about Orthotics. AOPA, together with its many partners among O&P manufacturers, patient care companies, and others entities committed to an evidence-driven future for O&P, will be funding one grant for each topic in amounts of up to \$60,000-\$75,000 for four of the five clinical areas identified under the Orthotics 2020 initiative: Osteoarthritis; Stroke; Traumatic Spinal Injuries and Plagiocephaly. A workgroup for the fifth category, Scoliosis, has been created, and will begin the drafting process for an RFP. Stakeholder subgroups for each of the categories will meet at the beginning of May to review submissions. The submission deadline was April 30, 2018 and grant awards will be announced in July.

Next steps include the formation of the Orthotics 2020 Medical Advisory Board. AOPA is excited to transition Orthotics 2020 into a vital enterprise to protect the orthotic services upon which patients depend from attack by payers, and to begin populating a stronger research base around issues on the value of the orthotic services we offer to patients.

COPL

In partnership with the Center for O&P Learning & Evidence-Based Practice (COPL), AOPA accepted applications for pilot grants for up to \$15,000-\$30,000 for ten O&P topics, including an open topic (multiple grants will be funded). Like the Orthotics 2020 grants, the submission deadline was April 30, 2018 and grant awards will be announced in July.

AOPA Co-OP, the Compendium of O&P

The AOPA Co-OP, a reimbursement, coding and policy resource, now has 288 active users. The most recent additions to the Co-OP include more in-depth information on each of the state pages, as the AOPA State Representatives program continues to grow and become more involved. A Member-to-Member page has been created for members to share resources created by AOPA members, for other AOPA members to use.

This members-only online resource serves as a collection of concise, but detailed information with links to supporting documentation about the topics most important to our members. The platform's key subject areas include Medicare, Medicaid, VA, DOD, Commercial Payors, Data/Evidence, Compliance, State Matters, Good Practices and Trending Topics. The crowdsourcing component of this project allows AOPA to garner the vast knowledge and experience of the membership body, vet that information and provide updates to the Co-OP on a regular basis.

Prosthetics 2020

The AOPA Medical Advisory Board will meet May 29-30 at the AOPA Headquarters in Alexandria Virginia. AOPA continues its commitment to Prosthetics 2020 to ensure that prosthetics are properly positioned for the future value-driven healthcare economy with four key goals – (1) improve the future reimbursement landscape for LEP; (2) match appropriate technology to patient needs instead of payer forced lowest cost technology to all patients; (3) define new patient segments benefitting from LEP technology; and (4) separate the O&P profession from DME in the minds of payers.

The RAND Study: Economic Value of Advanced Transfemoral Prosthetics

The RAND Corporation released its comprehensive, independent, validated study that establishes the value proposition for prosthetic services to amputees in September of 2017 and continues work on to explore the economic value of advanced transibial prostheses.

The final report, *Economic Value of Advanced Transfemoral Prosthetics*, has been published on the RAND website and is awaiting publication in the Journal of Neurosurgery.

Outcome Assessment Reporting System (OARS)

AOPA has been working with Dr. David Boone, BSPO, MPH, PhD and a group of computer science engineering students from the University of Washington to develop an application that will walk a clinician through an outcome measure, with written and video instructions, and create a report, which will include what the result means for the patient with references to the science supporting the measure. This report can then be printed or downloaded as a PDF for the patient's record. AOPA is excited to announce that it is in the beginning stages of beta-testing the Outcome Assessment Reporting System (OARS).

Nearly all of the materials are made available on a complimentary basis so it is a wonderful cost effective opportunity to instill a sense of a commitment to a value system documented by your written compliance and ethics program that is a win/win for your company and for your patients.
