# **Legislative Updates**

#### Medicare O&P Patient-Centered Care Act

On March 17, the House introduced the Medicare O&P Patient-Centered Care Act (HR 1990). This bipartisan legislation would improve access to, and quality of, orthotic and prosthetic care while simultaneously combating fraud and abuse. The bill is identical to legislation introduced in the House (HR 5262) and Senate (S 4503) last year. Thank you for your help getting this vital legislation re-introduced. Introduction in the Senate is expected in late May/early June, providing us with a much greater window of opportunity to pass the bill.

#### Webinars

AOPA continued its monthly advocacy series to provide our members with updates on our activities before Congress, provide insight into our strategy, and to educate our members on the legislative process. The next webinar will be held Wednesday, May 27 at 1pm ET.

#### Workforce/Diversity Policy

AOPA has been asked by members of the Congressional Black Caucus to develop a policy platform to address workforce and diversity issues in the O&P profession. In late 2020, AOPA drafted and shared a policy platform which would involve legislation and new programs developed by the Health Resources & Services Administration (HRSA) within the Department of Health & Human Services to create greater awareness of O&P careers. We look forward to working with the Biden Administration and the 117th Congress to further develop these proposals and enact them into law.

While all in-person PAC events were cancelled beginning in mid-March, the AOPA PAC has been working with legislators to coordinate group and one-on-one virtual meetings with key legislators. In the first quarter, our PAC meetings included:

- Rep. Mike Thompson (D-CA) (\$2,500): Rep. Thompson sits on the Ways & Means Committee and is the lead Democratic sponsor of the O&P Patient-Centered Care Act.
- Sen. Chuck Schumer (D-NY) (\$1,000): Sen. Schumer is the new Senate Majority Leader.
- Sen. Ron Wyden (D-OR) (\$1,000): Wyden is now the Chairman of the Senate Finance Committee, with jurisdiction over the O&P Patient-Centered Care Act.
- Rep. Robin Kelly (D-IL) (\$1,000): Kelly is a member of the Energy and Commerce Health Subcommittee and chair of the Congressional Black Caucus Health Braintrust.
- Rep. Tony Cardenas (D-CA) (\$1,000): Cardenas is a member of the Energy and Commerce Health Subcommittee.
- Rep. Anna Eshoo (D-CA) (\$2,500): Eshoo is chair of the Energy and Commerce Health Subcommittee.

## **Regulatory Updates**

## Brand Name Product Selection Not Required for Prior Authorization Requests

As a result of AOPA's outreach, the DME MACs have indicated that they will be removing the requirement for inclusion of product selection information with your prior authorization requests. AOPA is pleased by this development that will ensure continued flexibility for product selection within the Medicare prior authorization program and is encouraged by the willingness of the DME MACs to engage in constructive and effective communication with AOPA on important issues.

#### Clarification on Proper Billing of Prefabricated Orthoses

On March 11, 2021, the Durable Medical Equipment Medicare Administrative Contractors (DME MACs) and the Pricing, Data Analysis, and Coding Contractor (PDAC) published a joint correct coding bulletin regarding code descriptors that include the term "prefabricated, includes fitting and adjustment".

The bulletin indicates that HCPCS codes that include the term, "prefabricated, includes fitting and adjustment" are appropriately classified as custom fitted orthoses and therefore may only be used to describe orthoses that require customization and/or modification by a certified orthotist or other properly trained individual. Orthoses described by these codes that are delivered as OTS, without customization and/or modification must be billed using the appropriate not otherwise specified code (L1499, L2999, L3999).

#### New HCPCS Codes Effective April 1, 2021

As a result of the HCPCS code applications processed in CMS' Second Biannual 2020 non-drug and non-biological items and services review cycle, which includes orthotics and prosthetics, the following HCPCS codes will be effective for claims with a date of service on or after April 1, 2021:

- K1014 -Addition, endoskeletal knee-shin system, 4 bar linkage or multiaxial, fluid swing and stance phase control
- K1015-Foot, adductus positioning device, adjustable

#### **CGS Complex Post-Payment Reviews**

CGS, the DME MAC for Jurisdictions B&C, has announced that they will be conducting complex post-payment reviews for a series of prefabricated ankle-foot-orthoses. The reviews will be focused on claims for the HCPCS codes: L1902, L1906, L1971, L4396, and L4397. They will also be conducting post payment reviews for select prosthetic replacement sockets. The two socket replacement codes selected for review are L5700 and L5701.

If you receive additional documentation requests as part of these reviews be sure to respond to them, however suppliers should be reminded that CMS has implied that the DME MACs may allow for flexibility with extensions based on the supplier's ability to complete the audit; based on the current public health emergency.

# Noridian Complex Post-Payment Reviews

Noridian, the DME MAC for jurisdictions A &D, announced that they will be conducting post-payment medical record reviews of claims for the following three HCPCS codes: L0457, L0631, and L0650.

#### Lower Limb Prostheses Policy Updated

The Lower Limb Prostheses Policy Article now includes the following coding guidelines for L5968 (Addition to lower limb prosthesis, multiaxial ankle with swing phase active dorsiflexion feature) and L5986 (All lower extremity prostheses, multi-axial rotation unit ('mcp' or equal):

- L5968 describes a product that is used as an addition to L-code foot systems for lower limb prosthesis construction. The product provides multiaxial motion in the coronal and sagittal plane from articulating components. At transition of stance phase to swing phase, the product will increase the ankle's dorsiflexion angle and maintain it throughout swing phase. The product provides an accommodation of changing heel heights without the user's input. The predicate product is the Rincoe R-Hab Ankle.
- L5986 describes a product that is used as an addition to L-code foot systems for lower limb prosthesis construction. The product provides multiaxial motion in all three planes of motion, sagittal, coronal, and transverse. This code does not describe the multiaxial motion achieved from the inherent flexibility of the prosthetic keel or a split keel/heel prosthetic foot design. The predicate product is a device that was manufactured by Medical Center Prosthetic, which is represented in the coding narrative by "MCP."

#### **COPL Pilot Grant Program Funding Update**

The FY2021 COPL Pilot Grant RFP was published in February and proposals are being accepted in 10 areas of orthotic and prosthetic research including an open topic. For 2021-2022, the association is seeking proposals at two funding levels for one-time grants, \$15,000 and up to two exceptional proposals for \$30,000 for one year.
