Technical:

Become a technical presenter during the 2022 National Assembly. The workgroup is looking for a wide variety of education to accommodate all levels of experience. *New for 2022* is a session titled, Fabrication Tips and Tricks. This session will be based on your short videos featuring a

fabrication tip or trick on a fabrication method. Videos should be 3-5 minutes in length and can be on a tool, fabrication technique, design, or other technical related problem-solving method. The audience will select the winner(s) and cash prizes of \$500, \$250, and \$100 will be awarded. Indicate your interest on the submission form—your video can be updated later.

Digital O&P Care:

New for 2022, The Digital O&P Care Workgroup was created because AOPA has found that the process of digital transformation in our field has progressed to a point where this topic deserves a track on its own at the assembly. The lines around traditional topics like CAD CAM, patient data management, and design for manufacturing in 3D printing have blurred and current computer programs tackle multiple aspects of the patient care. Additionally, the innovations in digital technology that are being discussed and in progress are likely to combine multiple aspects of O&P even more so we need to get ready for the future. While the Digital O&P Care Workgroup is interested in a variety of education topics, they are specifically interested in the following.

Legislative Updates

During the fourth quarter, AOPA continued to advocate for the Medicare O&P Patient-Centered Care Act, meeting with over 35 members of Congress. In the House, *H.R.* 1990 expanded roster of cosponsors by four, bringing the total to 14:

- Rep. Adrian Smith (R-NE-3)
- Rep. Jackie Walorski (R-IN-2)
- Rep. Suzan K. DelBene (D-WA-1)
- Rep. Jefferson Van Drew (R-NJ-2)

S. 2556 also added Sen. John Thune (R-SD) as a cosponsor, bringing the total number of cosponsors on the Senate bill to 6.

Coding and Reimbursement

CMS & OSHA Released Rules Regarding Mandatory COVID-19 Vaccinations

On November 4, 2021, the Centers for Medicare and Medicaid Services (CMS) and the Occupational Safety and Health Administration (OSHA) released separate, but complementary regulations that established COVID-19 vaccination requirements.

The CMS rule applied to certain Medicare and Medicaid providers and suppliers who are regulated under specific health and safety standards known as Conditions of Participation, and O&P suppliers and providers were not included on this list. The CMS Fact Sheet regarding the Interim Final Rule which includes a comprehensive FAQ document may be accessed here.

The OSHA rule applies more broadly to all employers with 100 or more employees (large employers) and is not limited to companies that operate in the healthcare space. A helpful fact sheet including a summary of the employer requirements established by the OSHA rule may be accessed <u>here</u>.

It is important to point out that both of these vaccine mandates have been placed on hold as they are being challenged in the courts.

AOPA remains in support of all measures to ensure the safety and well-being of all of its members and their patients, including COVID-19 vaccination.

2022 Medicare DMEPOS Fee Schedule Updated

On December 2, 2021, the Centers for Medicare and Medicaid Services (CMS) announced the 2022 Medicare Fee Schedule update for Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS). The 2022 Medicare DMEPOS Fee Schedule will increase by a net total of 5.1% for claims with a date of service on or after January 1, 2022. The 5.1% increase is the result of a CPI-U increase of 5.4% from June 2020 to June 2021 and a -0.3% productivity adjustment. AOPA previously reported an assumed net increase of 5.1% but it has now been officially confirmed by CMS.

In addition to the 5.1% increase to the Medicare DMEPOS Fee Schedule, on December 10, 2022, Congress passed a bill that will extend the delay of the 2% Medicare sequestration-based reimbursement reductions that were scheduled to be re-implemented as of January 1, 2022. The bill will extend the moratorium on sequestration reductions through March 31, 2022 and reduce sequestration reductions to 1% from April 1st through June 30, 2022.

On November 24, 2021, the DME MACs and the PDAC released a coding reminder and new guidelines for thirty HCPCS codes describing Elbow, Shoulder, Shoulder-Elbow-Wrist-Hand and Shoulder-Elbow-Wrist-Hand-Finger Orthoses. Code Verification Reminder for L6715 and L6880

Effective for claims with dates of service on or after January 1, 2022, the only products that may be billed using codes L6715 (terminal device, multiple articulating digit, includes motor(s), initial issue or replacement) and/or L6880 (electric hand, switch or myoelectric controlled, independently articulating digits, any grasp pattern or combination of grasp patterns, includes motor(s) are those that have received a code verification by the PDAC and are listed on the PDAC website.
